Privacy Statement

No.11 London is fully committed to respecting the privacy of its visitors to this website. This privacy statement sets out the type of information we may collect and hold, and how it is used.

It also contains contact details so you can contact us if you have any queries or concerns about your personal information. Any personal information which is given will be treated with the highest standards of security and confidentiality, in accordance with the Data Protection Acts 1998 & 2003.

Data Protection

In various sections of this site, we use electronic forms to gather personal information for purposes directly related to the services that we supply. Any information that we do collect is for internal use only and is not passed on to third parties without your prior consent. You have the right to ask us at any time to not contact you by way of direct marketing.

Completion and submission of any form is entirely at the discretion of you, the user.

No.11 London believes that the responsible use of personal information collected on its web site is critical to its business objectives and reputation. As part of our commitment to privacy, we have adopted this online privacy statement. The extent and type of information we receive from you on our external web sites depends on the information you provide to us through our contact mailboxes and/or through the registration processes on our site.

We only use your personally identifiable information to respond to your requests and to provide you with information about No.11 London services, unless we obtain your permission to use your personal information for other purposes. For example, if you send us an e-mail message requesting information about No.11 London, we will use your e-mail address and other information you supply to respond to your request.

If we intend to use your personal information to inform you about other No.11 London services, we will notify you and give you an opportunity to decline to receive such communications.

If you send us a resume or curriculum vitae (CV) to apply for employment or membership of No.11 London, we will use the information provided to match you with available opportunities.

Cookies and Web Logs

If you choose to view the No.11 London web site with any accessibility options, cookies (i.e. small text files placed on your computer when you first visit the site) will be used to store these options. These are only session cookies and will be deleted when you close your web browser.

As with most websites, the No.11 London website automatically logs certain information whenever someone visits the site. This information is used for site statistics and does not include anything from which users could be identified. This logged information is not passed on to any third party unless required by law.

Most browsers now recognise when a cookie is offered and permit you to refuse or accept it. If you are not sure whether your browser has this capability, you should check with the software manufacturer, your company's technology help desk or your internet service provider.

Cookies are primarily used to enhance your online experience and are not used to track the navigational habits of identified visitors, unless we obtain your permission to do so.

If you visit our site to read or download information, such as news stories or articles, much of the information we do collect is statistical only (e.g., the domain from which you access the internet, the date and time you access our site, and the internet address of the web site from which you linked directly to our site) and not personally identifiable. We use this information about the number of visitors and their use of the sites in aggregate form to make our sites more useful and attractive to you.

Security

No.11 London takes the necessary security measures to safeguard your data, from risk of loss, destruction, unauthorised access, modifications or disclosure.

In addition, No.11 London has technological and operational security policies and procedures in place to protect your personally identifiable information from loss, misuse, alteration or unintentional destruction. Our personnel, who have access to the data, have been trained to maintain the confidentiality of such information.

No.11 London understands the importance of protecting children's privacy, especially in an online environment. Our site are not intentionally designed for or directed at children under the age of 13 years. It is our policy never to knowingly collect or maintain information about anyone under the age of 13.
